
CITI Online Human Research Course: Educational Requirements for Research Activities

All individuals conducting human subjects research at Maimonides Medical Center are required to complete the CITI online human research course. The Collaborative Institutional Training Initiative (CITI) provides web-based education on human subjects research, available for all Maimonides employees and trainees, including residents, fellows, and medical and nursing students, to advance their knowledge of ethics, regulations and principles related to human subjects research.

Follow the instructions below to complete the human subject research certification required prior to beginning your residency at Maimonides. Email irb@maimonidesmed.org if you have any questions.

Instructions

- 1. Go to the following web site: https://www.citiprogram.org.
- 2. Click on "Register" and enter the requisite information. The participating Institution is Maimonides Medical Center.



3. For Question 1, choose "BioMedical Research Investigator". a. If you would like to take other optional courses, you can choose them via Questions 2-6. Please note that you may require additional certifications if you end up becoming a member of study staff for clinical trials or Public Health Services funded studies.
